Camp 2021 COVID Protocols

A Note from the Directors:

Thank you for choosing Camp Garrett! We're excited to have your camper(s) with us this summer, and know that we'll have a wonderful time together. Running camp during the COVID-19 pandemic requires some adaptations to policies and procedures in order to ensure we are operating safely. These policies and procedures are adherent to the current CDC, State, and local guidelines, but are subject to change if these bodies issue edits to their recommendations. Garrett Williamson also reserves the right to revise policies and procedures above current CDC, State and local guidelines should it determined that such changes would further enhance safety at Camp Garrett. If any guidelines change, we will ensure you receive the updated protocols, and will require an updated attestation form.

Please thoroughly read this document, sign the accompanying attestation form, and reach out to us if you have any questions.

Pick up and Drop off

- An attestation form will be sent to you each morning via HiMama, our parent partnership software, which needs to be completed prior to arrival. This form will ask if your child has any symptoms of COVID-19 or has had exposure to anyone with symptoms or a positive diagnosis, and if your child has traveled out of state.
- Park your vehicle and accompany your camper(s) to the Pavilion each morning. Your temperatures will all be taken by a staff member, and another staff member will bring your camper(s) to their group. You must wear your mask when approaching the Pavilion or buildings.
- When picking up, go to the Pavilion and a staff member will bring your camper(s) to you.
 - o If a staff member is not at the Pavilion, or if you are picking up from After Care, please ring the bell on the front door and a staff member will bring your camper(s) to the front. You must wear your mask when approaching the Pavilion or buildings. Due to the pandemic, you are only permitted in the building if there is an emergency.

Health Screening

- If you have any of the following symptoms, you are not permitted to come to Camp. If you arrive and are showing these symptoms, you will be sent home.
 - o Fever of 100.4 degrees Fahrenheit or higher
 - o Dry cough
 - Shortness of breath
 - Chills
 - Loss of taste or smell

- Sore throat
- Muscle aches
- o Rash of an unknown origin
- Diarrhea
- If you or anyone in your household has tested positive your child cannot come to Camp Garrett until they are 72 hours symptom-free without medication, and have quarantined for 14 days.
- If you have been in contact with anyone who has tested positive, you will need to quarantine for 14 days before coming to camp.
 - If you do not develop symptoms, you can return after the 14 day quarantine. If you do have symptoms, or test positive, you cannot come to Camp Garrett until you are 72 hours symptom-free without medication, and have quarantined for 14 days.
- If you have traveled out of the state of Pennsylvania, as long as you are following masking and social distancing guidelines and have not been exposed to anyone suspected of having COVID-19, you may return to camp as scheduled.

Social Distancing

At camp, our main goal will be to be, as often as possible, <u>outside</u>, <u>masked</u>, <u>and distanced</u>. **As it stands now**, we are planning to operate at a limited capacity, so camp is scheduled to have much fewer people on-site than usual. Unless there is a drastic decrease or eradication of covid-19 by summer, we will be ensuring that outside of pods, all campers and staff will maintain 6 feet of distancing at all times. All campers will be asked to wear masks as often as possible, and staff will be wearing masks at all times, which include but are not limited to:

- When campers are inside buildings with the exception of when they are eating
- When outside and taking part in an activity that does not allow for 6 feet of social distancing
- When taking part in activities that are thought to increase droplets into the air, including singing and cheering

We ask that on weekends and in the evenings after camp, you and your family are adhering to CDC and PA State guidelines surrounding social distancing.

Podding

Campers will be placed into a small group while at camp, and then assigned to a "pod". This pod will be made up of two groups of campers, and will remain strictly in place for the entire two-week session. This is to limit contact but to allow friendships and connections to grow. Pods will do activities together, eat together, swim together, etc.

Sanitizing

Besides masking and social distancing, we will take additional precautions to sanitize frequently throughout the day. We will be:

- Washing hands before and after each meal
- Washing and/or sanitizing hands before and after activities that use equipment
- Sanitizing equipment and surfaces between each use
- Sanitizing door handles, light switches, and other frequently-touched areas.

Food Service

Camp Garrett provides breakfast, lunch and a snack each day to every camper. This year, we will be working hard to ensure that all food is served directly to your child to limit contamination possibilities, and snacks will be single-package items such as granola bars, bagged goldfish, a single piece of fruit, etc.

All plate ware and silverware will be thoroughly washed and sanitized after each use.

Potential or Positive Case of COVID-19

If while at camp, a person experiences COVID-19-like symptoms, the child will be removed from their group and made comfortable in a separate area. We will contact caregivers and require that the camper will be picked up from camp within <u>one hour</u>. Your emergency contacts must know of the one hour pick up requirement. The child may only return to camp after:

• 10 days of isolation and 72 hours without a fever, without the use of fever-reducing medications and symptoms have improved.

If a staff member or camper receives a positive COVID-19 test, all members of that pod, including employees will be notified and asked to quarantine for 14 days.
